#### Subject: Public hearing on the "Reform of the European electoral law"

Dear Professor Dr. Pukelsheim,

The Committee on constitutional affairs of the European Parliament (AFCO) is organising a public hearing on the "reform of the European electoral law" that will be held on 4 December 2014 from 9.00 pm to 12.30 pm in the premises of the European Parliament in Brussels.

As the Chairwoman of the Committee, I have the pleasure to invite you to participate as a speaker at the abovementioned hearing. Your presentation should be limited to a maximum of 20 minutes and we kindly ask you to respect this limit.

The analysis of further reform of the European electoral law might be structured around the following categories or "classes" of intervention:

- Practical arrangements not requiring changes to the law in order to strengthen the visibility of the European elections and the public awareness thereof;

- Changes to secondary law: Right to vote and stand as a candidate in elections to the European Parliament for citizens of the Union residing in a Member State of which they are not nationals (Regulation 93/109/EC as amended);

- Measures implementing the Electoral Act proposed by the European Parliament and adopted by the Council after consulting the Commission (Article 14 Electoral Act);

- Changes to the Electoral Act in order for example to establish a level playing field for parties and candidates;

- Changes to the Treaties for example to modify the number of Members of Parliament with a view to introduce transnational lists.

A preliminary draft programme of the hearing will be sent out in due time.
